Progress on Actions from the previous (Ottawa) meeting are recorded in Appendix A -Actions still relevant are highlighted. It was agreed that the notes of the meeting would be kept brief and the focus would be on listing the actions. New Actions generated during this meeting are recorded in Appendix B.

1. Welcome, introductions and agenda (IJ)

All applauded the excellent organisation of the Operational Management Group (OMG) meeting and the Technical meeting by the BRGM Team and in particular the work of Dominique Verhelst.

2. Welcome (FR)

3. Overview of minutes and actions from Ottawa – review agenda (JB)

The actions from the Ottawa were all placed within the items of the agenda and reviewed then.

4. Update on OneGeology, its current position and work in train (IJ)

1G management meeting notes and actions March 2008



IJ gave a brief presentation of the aims and current status of 1G (which will be placed on the website for download). The overall position is extremely positive. After the Commonwealth Directors meeting in Keyworth this week numbers participating in 1G may rise to 81. 1G had received a lot of attention from major speakers and the media at the launch of IYPE. Technical work is very much on track (in fact significantly in advance of it). It was agreed that we need to record in some way the significant contribution of some nations to 1G.

5. Funding and support actions (IJ)

IJ had consulted lawyers on the possible options, pros and cons for the legal status of 1G post IGC and a paper would be circulated in a few weeks. Participants from other jurisdictions were asked to add options from their nations.

6. Relationships with other Groups (JB)

JB presented a preliminary list, which will be circulated for comment and additions

7. Communications and website (HT)

It was agreed that translations of key texts (posters and leaflets etc) should be done. The text for these is available on the website for those doing the translations.

8. Intellectual Property Rights (JB)

JB provided an outline of the basic position; this would be progressed by email.

9. Strategy for technical and practical assistance for developing nations (KB)

Recent work and developments by the Technical Group are very relevant to this item and will require action by the OMG.

10. Organisation, Governance, Roles and Responsibilities (IJ)

Two draft documents – Participation in 1G and also Steering Group Terms of Reference were presented and discussed. These drafts will be circulated and require comment by the OMG prior to being released/presented to the Steering Group.

11. Report from Orleans Technical Workshop (TD)

The work of the Technical Group was presented and discussed. Progress was excellent. A number of decisions/actions were required of the OMG as a result of the Workshop in Orleans (see actions). The estimate of nations serving was difficult to state but may exceed 40 by the time of the IGC – well over the original target number.

12. Planning for the 33IGC

A draft paper on the potential events at the 33 IGC was presented and discussed in detail. Several important obligations and actions resulted.

13. Any Other Business

Sustainability of 1G - the need for a paper on the 2-4 year objectives and business model of 1G post-IGC was discussed and agreed. The idea by US to have a national version of the

1G logo by adding the national abbreviation was not regarded as appropriate for a truly international logo and was not agreed by the OMG. Similarly the OMG agreed that the draft logo for 1G-Europe should not amend the current global logo.

14. Date Next Meeting

This would be in Oslo at the IGC at a time to be agreed once other IGC events had been fixed. The meeting after that (subject to decisions of Directors/Steering Group at the IGC) would be in Italy.
